Invitation to Join Utah Aerospace & Defense Association's Board of Governors-Chairman Summers

Chairman Summers stated the county has been invited to join the Aerospace and Defense Association Board. The cost is \$10,000 from the county. The Aerospace industry is second in Utah to agriculture. Box Elder County has many involvements in this sector and supports the local businesses to join this board.

Brigham City Storm System Project on 1400 W: Easement, Infrastructure Dedication & Surplus Property Request (Brigham City will Present)

Chairman Summers explained that Brigham City has asked Box Elder County to trade property with Brigham City and grant an easement and allow access to a drain pipe for maintenance.

MOTION: Member Perry made a motion to allow the County Attorney's office to work with Brigham City in negotiations on the Storm Drain Project on 1400 West. The motion was seconded by Member Bingham and unanimously carried on a roll call vote of Chairman Summers voting Yea, Member Bingham voting Yea, and Member Perry voting Yea.

Approve Funding for BRAG for Regional Economic Development/Quality Growth Director-Chariman Summers
